

STATEMENTS OF SUPPORT FROM PARTNERS IN NALOXONE FOR LIFE INITIATIVE

Thornton Police Department:

The Thornton Police Department is pleased to announce that, in partnership with the Colorado Attorney General's Office, we will be equipping our officers with the drug Narcan to combat the effects of drug overdoses in the field.

The amount of overdoses due to heroin and its derivatives such as Fentanyl have been increasing and making headlines across the country. Thanks to our partnership with the Attorney General, we are now equipping our patrol cars with Narcan and training our officers on the administration of the drug. The Thornton Police Department is committed to delivering high levels of service to our citizens and protecting the men, women and children in our community. We feel that the ability to administer the potentially lifesaving drug of Narcan as the first responder on scene is one more tool we can use to be able to render immediate aid in overdose situations until medical personnel arrive on scene.

We are proud to take a proactive leadership role in training our officers on the use of Narcan.

Harm Reduction Action Center:

A very special thank you to the Attorney General's Office for this initiative as Colorado is in the midst of an overdose epidemic. Since 2000, 10,544 Coloradans have died due to overdose. Naloxone is a safe and easy-to-use medication used to treat an opioid overdose in an emergency situation. There is no potential for abuse and it is not a scheduled drug. Point blank, Naloxone saves lives.

In 2013, Colorado passed the law allowing third parties – such as mothers, homeless service providers, law enforcement – to have access to naloxone. Then in 2015, we passed a law allowing standing orders for access to naloxone for pharmacies and harm reduction organizations. All 100 Colorado state legislators voted in support of standing orders. There are currently over 220 pharmacies in the State of Colorado that opioid users and their loved ones can access Naloxone today. Many overdoses are witnessed and Naloxone in the hands of drug users is essential as we battle this epidemic.

At least 31 states in the United States have law enforcement carrying Naloxone. Currently there are 20 law enforcement departments carrying Naloxone in the state of Colorado. Thanks to this initiative from the AG's office, in 6 weeks there will be over 60 departments equipped to respond to an overdose in primarily rural counties.

We are thankful for this partnership as public health and law enforcement are pushing forward together for a healthier and safer Colorado.

The Colorado Health Institute:

The Colorado Health Institute is the nonpartisan health policy research organization based in Denver that first mapped the opioid deaths in Colorado. Its CEO, Michele Lueck, said the maps showing the spread of deaths across the state between 2002 and 2014 were shocking – and heartbreaking.

“The data behind these maps make one thing very clear,” said Michele Lueck. “This is a widespread problem that is leading to tragedy across Colorado. It is also a clear health policy challenge. The increased access to Naloxone, especially to first responders, is a step in the right direction.”

RX Assurance:

Denver-based RxAssurance (www.rxassurance.com) teamed up with the Colorado Attorney General’s Office to offer an app-based tracking mechanism for first responders or laypersons who administer Naloxone for an opioid overdose.

“We are thrilled to partner with the Attorney General’s Office to give first responders an app based guide for properly administering Naloxone to victims of opioid related overdoses which includes a mechanism for tracking opioid overdose reversals over time,” said Bob Goodman, CEO of RxAssurance. “The rich, real-time data provided by these reports will help the state make further gains in combatting the opioid epidemic. We created RxAssurance to offer a family of solutions to help physicians, emergency response agencies, patients, and their family members and loved ones have a safer experience when using opioid medications.”

The free, award-winning app OpiRescue was created in 2015 to help combat the rise in opioid-related overdose deaths. Originally released as an instructional guide to reverse opioid overdoses for family and friends of those who are on opioid medication, or who may have become addicted to opioids.

At the request of the Attorney General’s Office, OpiRescue has been expanded to now offer first responders (and the general public, anonymously) a way to report opioid overdose reversals. First responders in Colorado can include their agency and ID and get a report emailed to them for their files. The app tracks opioid overdose reversals to the nearest cross-streets, compiling valuable data for outcome tracking.

Overdose is common among people who use illicit opioids such as heroin, and among those who misuse medications prescribed for pain, such as oxycodone, hydrocodone and morphine.

OpiRescue is available for download at www.opirescue.com at no cost for iPhone and Android. In addition to tracking and reporting, it offers information about signs and symptoms of overdose, instructions to administer Naloxone and Substance Abuse Mental Health Services Administration (SAMHSA) resources and is available in English and Spanish. In 2015, the app won the top prize in SAMHSA’s Opioid Overdose Prevention Challenge.

RxAssurance, the creators of OpiRescue also created a solution, OpiSafe, to help care providers better manage opioid prescribing and monitoring. OpiSafe performs risk stratification for each patient on the basis of Morphine Equivalent dosing ranges, Pain and Function scores, Opioid Misuse Risk scores and automated.
